#### Amendment to zoning ordinance – Wind Energy Conversion Systems

Motion by Mr. Ellick to accept the wind energy conversion systems amendment to the zoning ordinance as presented. Seconded by Ms. Zenker. Roll call vote Rideout – no, Straub – yes, Gunnell – yes, Zenker – yes, Ellick – yes. Resolution accepted 4 to 0.

#### Motion to revise fee schedule

Motion by Mr. Ellick to approve revising fee schedule for site plan reviews. Motion was seconded by Ms. Zenker. Motion carried 5 to 0.

#### Authorization for Treasurer to attend MMTA fall conference

Motion by Mr. Straub to approve Treasurer attending the fall conference of MMTA at a cost not to exceed \$800.00. Seconded by Mr. Ellick. Motion carried 5 to 0.

#### Resolution for authorized financial institutions

Motion by Ms. Zenker to approve resolution authorizing financial institutions for deposits. Seconded by Mr. Gunnell. Discussion – Mr. Rideout expressed the opinion that banks with poor ratings should not be included authorized institutions. Roll call vote: Straub – yes, Gunnell – yes, Zenker – yes, Ellick – yes, Rideout – no. Resolution accepted 4 to 1.

#### POW/MIA Resolution

Motion by Mr. Straub to approve POW/MIA resolution as presented. Motion seconded by Mr. Rideout. Role call vote: Gunnell – yes, Zenker – yes, Ellick – yes, Rideout – yes, Straub – yes. Resolution carried 5 to 0.

#### Authorization for funding - \$600 for grass rig brakes

Motion by Mr. Rideout to approve funding of \$600.00 for brakes for the grass rig. Seconded by Ms. Zenker. Motion carried 5 to 0.

#### Authorization for funding – additional road construction

Motion by Mr. Rideout to approve funding not to exceed \$22,300.00 for road repaid/construction on Wiersma from White Creek Ave west until funding are exhausted. Seconded by Mr. Straub. Motion carried 5 to 0.

Kent County Investment Pool Agreement

Motion by Ms. Zenker to approve Kent County Investment Pool Agreement. Seconded by Mr. Gunnell. Discussion – concern was expressed by Mr. Straub & Mr. Rideout the document was outdated and put the Township in an unfavorable position when it came to withdrawing funds. Motion failed 2 to 3 with Mr. Straub, Mr. Ellick and Mr. Rideout descending.
