General Noise Ordinance – Mr. Ellick opened the public meeting on the proposed ordinance at 7:40 PM. There were 53 residents in attending the public meeting. Of those attending thirty individuals expressed an opinion on the noise ordinance with three individuals in favor of some type of ordinance and the majority opposed to it. The majority of those speaking against the ordinance had some connection to the motorcycle / dirt bike sport and did not want their right to enjoy this sport impacted by a noise ordinance.

The supervisor closed the public hearing at 8:20 PM.

Motion by Mr. Rideout to amend the fire department budget to increase capital outlay/equipment account by \$25,100.00. Motion seconded by Ms. Zenker. Motion carried 5 to 0.

Motion by Mr. Straub to transfer \$20,000.00 from the fire fund to the general account. Motion was seconded by Mr. Rideout. Motion carried 5 to 0.

Motion by Ms. Zenker to close the township offices on January 15, 2008 for the presidential primary election. Motion was seconded by Mr. Gunnell. Motion carried 5 to 0.

Motion by Mr. Rideout to establish a capital building fund. Seconded by Mr. Straub. Motion carried 5 to 0.

Motion by Ms. Zenker to transfer funds currently held in the certificate of deposit at Mercantile Bank from the general fund to the building fund (\$260,043.37 plus accumulated interest). Motion was seconded by Mr. Straub. Motion carried 5 to 0.
