Significant Events and/or Alarms

- On January 6, Chief Drake delivered two fire safety presentations to the En Gedi program at Cedar Springs Beach Elementary. This presentation discussed the fire department operational and staffing methods, home fire safety, exit drills, 911 center, and pre-fire prevention tips. - On January 17, SFD responded to a Motor Vehicle Accident (MVA) on White Creek north of 16 Mile Road. Original dispatch information indicated that one of the parties involved was unresponsive and that the vehicles collided head-on. Due to the severity indicators and the proximity of the crash to the City of Cedar Springs Fire Department (CSFD), aid was requested from CSFD. Personnel from SFD arrived on scene and determined that the unresponsive party was deceased after suffering massive head injuries. The other driver had minor lacerations. Both vehicles were solely occupied by the driver. SFD provided aid to the party with minor injuries and assisted KCSD with lighting.
- On January 25, Chief Drake attended the Kent County Dispatch Authority (KCDA) Board Meeting representing the Kent County Township Fire Departments. On the agenda for this meeting was a presentation by Prima Civitas, the vendor hired to perform an examination on the consolidation of the two remaining Public Safety Answering Points (PSAP) and dispatch centers in Kent County. In short, the executive summary of this study is recommending the consolidation of these two PSAPs. Upon conclusion of the report, two resolutions were approved:

- Acceptance of the report
- Authorization for the KCDA Board Chairman to petition the Kent County Commission Chairman to provide funding for the KCDA as current funding streams (phone surcharge) will be insufficient by 2020
