## Significant Events and/or Alarms

- On May 24, MI-OSHA inspector Ryan Brzak arrived at SFD for an un-announced inspection due to an employee originated anonymous complaint alleging work place safety and Part 74 (Fire department safety standards) procedural violations. Mr. Brzak, DC Paige, and Chief Drake participated in cordial discussion and initiated a review of the complaint. Below is a copy of the alleged violations:
  1. There are allegations that training records are being falsified.
  2. Asbestos tile was disturbed during a recent remodel.
  3. The building foundation is in a weakened state and at times, the mortar has cracked and allowed moisture and other contaminants into the building.
  4. The upper station had floor grates that were rusted almost all the way through and have had firefighters fall through them, with minor injuries.
  5. The assistant chief cannot pass the respirator portion of the NFPA physical, is full time, and is not supposed to wear an SCBA respirator, but does so anyways.
  6. Unsure if ladders and hoses have been tested annually as required.
  7. The stations has black mold issues which continues to get covered up.
  8. There are also firefighters that are performing their duties with outdated gear, some by multiple years.

Each specific complaint was considered individually and discussed. Items 1, 5, 6, and 8 were refuted by providing copies of documents, records, and files that proved otherwise. Item 1 was so generic that Mr. Brzak was uncertain on how to investigate, random training records were selected and reviewed. Items 3, 4, and 7 were refuted by a building site walk through. Although the specifics of item # 2, the building remodel were proven to be done with compliant asbestos remediation, the overall scope of asbestos workplace safety standard was found to be deficient. Specifically, the Township is lacking an Asbestos Building Survey (MiOSHA Part 305) for all buildings constructed prior to 1980, and a safety course for employees performing general cleaning within those buildings. A final report is expected within 4-6 weeks

- On May 31, a Spaghetti Dinner fundraiser event for the purchase of an Automatic Chest Compression Device (ACCD) occurred at the Big Boy restaurant on 17 Mile Road. A total of \$ 1,584 was donated at this event. Combined with other promised funds, the total amount is over \$ 4,000. Attendance was strong through the night with 192 dinner tickets sold. This event also included a raffle for some spectacular door prizes donated by area merchants, SFD vendors, and others by FF Hunt's personal and professional contacts. The donators include: 1800-Board-UP, Meijer, White Creek Hardware, Walker Street Dairy Queen, Pridgeon & Clay, Z's Bar & Restaurant, Tractor Supply, and Kendall Meijer
- May alarms started with high activity but soon slowed resulting in an average month for alarms.
