Significant Events and/or Alarms

- On 9-14-17 SFD provided live fire extinguisher training to the office staff at Saint John Paul II church on 17 Mile Road.

- On 9-23-17, SFD responded to a report of a two vehicle crash at the intersection of M-46 & Pine Island Drive at 1238 PM. Dispatch information included a report of wires down and a person pinned in the driver seat of a pick-up truck after crashing into a utility pole and the vehicle was burning. Prior to arrival of SFD units, a passerby stopped to try and extricate the driver in the burning vehicle. The rescuer indicates that the driver was unconscious upon his arrival at the driver's door. He reports further that he banged on the window after pulling on the door handle only to find it locked. Unable to arouse the driver, he smashed out the window and unlocked the door. The rescuer states that the flames from the engine compartment were now licking at the feet of the driver through the fire wall. The rescuer states that initially he was unsuccessful in his attempts to move the adult male driver. Through perseverance and the commitment of one last mighty pull of the rescuers 400 pound plus stature, he was able to extricate the driver without any burn injuries. The actions of this individual are truly heroic. The response time of SFD would have been too late for a successful rescue. On arrival of SFD, the initial engine compartment fire had spread rapidly to the cab and bed of the truck due to a ruptured, full fuel tank from the impact. The driver of the truck was transported to Butterworth hospital with non-life threatening injuries. The fire was extinguished by SFD personnel with assistance of Kent City FD providing additional water.
- On 9-10-17, six personnel visited the Meijer store and distributed fire prevention and recruiting material for 5.5 hours.
- On 9-20-17 SFD received simultaneous medical alarms and was able to mitigate both without mutual aid.
- FF R Schmidt and FF Elliott have started the 2017-18 MFFTC academy at Plainfield FD
- FF Grady was removed from probationary status after successful completion of MFFTC FF I & II and SFD Field Training Program
- Candidate Bryan Cebrero approved to hire at September board meeting.
