## Significant Events and/or Alarms

- FF Hunt provided station coverage for approved vacation leave on two dates for 13 hours.
- The awarded FEMA grant has been requested to disperse funds with the expectation of the SCBA equipment to arrive next week. Funds need to be dispersed 30 days from deposit by the awarded department. SFD should expect an invoice from the City of Cedar Springs for the shared portion within 10 days.
- The new Tender 1 is expected to be delivered by February 15, 2019. The last item to be corrected is the maximum speed of 63 MPH. Currently, the truck will go over 80 MPH.
- SFD provided mutual aid to Sand Lake FD at a residential structure fire on February 24, 2019 on West Stanton Road
- Deputy Chief Paige is enrolled in a MFFTC class to obtain the Instructor II Credential. This is a 40-hour course hosted by the City of Walker FD. Class dates are two separate weekends in February.
