Outside of Station Functions, Significant Events, Alarms:

- On 6-25-20, and 6-27-20 respectively, FF Nix successfully passed the MFFTC Fire Academy written and practical exams.
- On 6-10-20, SFD responded to the far north east corner of the township for numerous emergency calls after a fierce storm front passed through the area. An incredible amount of tree damage was observed which of course brought down many power lines. SFD responded to 10 wire trouble alarms immediately following the storm passage and an additional two the next day. SFD was able to respond to all of these alarms without mutual aid as four personnel were available.
- On 6-24-20, eleven personnel completed the annual NFPA 1582 exam on the Bio-Care bus in the upper parking lot. Three other personnel are scheduling at other sites due to conflict.
- Cedar Springs FD assisted Solon FD at a medical call involving an electrocution on 16 Mile Road
