- Red Flannel Days Parade was attended with SFD Engine 1, Medic 1, and Brush Unit 1 with 4 personnel and a few other civilian riders on October 6, 2018.
- In conjunction with Fire Prevention Month, Chief Drake presented a fire safety review with Mrs. Martin's Kindergarten class at Cedar View Elementary on October 9, 2018.
- On October 13, the annual Fire Prevention Month Safety Exhibition at the Moose Lodge in Sparta was hosted by Algoma Township. Solon FD provided a vehicle extrication demonstration using a junk car and the cordless extrication tools. This demonstration was well attended by the crowd. 4 personnel, 6 hours.
- On October 17 @ 1256 hours, SFD responded to a structure fire alarm at 990 Seventeen Mile Road N.E. and extinguished a small fire in the attic. SFD was assisted by Algoma, Kent City, Sand Lake, and Cannon fire departments. Fire loss is estimated at \$ 10,00.00.
- Four members of SFD participated in the annual fundraiser event on October 20 in Cedar Springs titled the "Ricker's Run". This annual event helps raise awareness for the battle against childhood cancer for both the local community family and the general population. The uniqueness of the participation by our team was their desire and ability to complete this race while wearing all of their protective ensemble and Self Contained Breathing Apparatus.

- On October 28 @ 1631 hours, SFD responded to a structure fire alarm at 476 Twenty-Two Mile Road. On arrival, SFD found a 800 sq. ft. structure with dark, acrid, brown smoke puffing from all four sides of the structure. A quick walk around by the incident commander found the initial start of flames in one corner of the building at the roof level. An exterior attack with 1.5" hose lines was made through the windows of the room of origin. After initially knocking down the flames, the crew entered the structure to ventilate and to confirm extinguishment. SFD received automatic aid from Sand Lake, Kent City, and Algoma, and Plainfield fire departments. SFD spent a total of 4.25 hours from dispatch to clean up time at the station. Fire loss is estimated at \$30,000.
- On Halloween night SFD personnel set up static displays in both the Santree and Vista View developments. All of the "Trick or Treaters" were provided with a demonstration of the trucks/equipment, safety literature, recruiting, and of course some candy that was donated by Meijer.
