RESOLUTION NO. 19-03

A RESOLUTION TO COLLECT EITHER 100% OR 50% OF THE SCHOOL PROPERTY TAXES IN THE SUMMER OF 2019 AS REQUESTED PURSUANT TO ACT 451, PUBLIC ACTS OF MICHIGAN, 1976 AS AMENDED.

WHEREAS, the Kent Intermediate School District has requested the Township Treasurer of Solon Township to collect the imposed summer property tax levy in 2019 of all school district property taxes by resolution; and this request was made prior to January 01, 2019 to collect 100 percent (100%) of the school property taxes and determined to be in the best interest of the Kent Intermediate School District.

WHEREAS, Cedar Springs Public School District has requested the Township Treasurer of Solon Township to collect the imposed summer property tax levy in 2019 of all school district property taxes by resolution; and this request was made prior to January 01, 2019 to collect 100 percent (100%) of the school property taxes and determined to be in the best interest of the Cedar Springs school district.

WHEREAS, Grand Rapids Community College has requested the Township Treasurer of Solon Township to collect the imposed summer property tax levy in 2019 of all school district property taxes by resolution; and this request was made prior to January 01, 2019 to collect 100 percent (100%) of the school property taxes and determined to be in the best interest of the Grand Rapids Community College.

WHEREAS, Kent City Community School District has requested the Township Treasurer of Solon Township to collect the imposed summer property tax levy in 2019 of all school district property taxes by resolution; and this request was made prior to January 01, 2019 to collect 50 percent (50%) of the school property taxes and determined to be in the best interest of the Kent City Community School District.

NOW, THEREFORE, BE IT RESOLVED:

1. The Solon Township Board approves collection of summer taxes for said Kent Intermediate School District, Cedar Springs Public Schools, Grand Rapids Community College and Kent City Community Schools.

2. That the charge to Cedar Springs Public Schools and Kent City Community Schools will be \$3.00 per parcel and \$.35 per parcel charge to Kent Intermediate School District and Grand Rapids Community College.
