**RESOLUTION NO. 19-09**

**RESOLUTION TO APPROVE AMENDMENT OF TOWNLINE DIVISION  
AGREEMENT FOR 16 MILE ROAD**

WHEREAS, prior to 1931 Solon Township entered into a Townline Division Agreement with Algoma Township whereby Solon Township took responsibility for maintaining the following portions of 16 Mile Road along its South Townline:

(0.55 mi.) - from Pennington Avenue East to South  $\frac{3}{4}$  line Sec. 33

(1.21 mi.) – from South  $\frac{1}{4}$  line Sec. 34 East to turnaround; and

WHEREAS, pursuant to the Townline Division Agreement, Algoma Township took responsibility for maintaining the following portions of 16 Mile Road along its North Townline:

(1 mi.) – from North  $\frac{1}{4}$  line Sec. 4 East to North  $\frac{1}{4}$  line Sec. 3

(1 mi.) – from White Creek Ave. East to Northland Dr.; and

WHEREAS, the Boards of both Solon Township and Algoma Township wish to amend the existing maintenance and construction responsibilities for their mutual Townline along 16 Mile Road.

IT IS, THEREFORE, RESOLVED AS FOLLOWS:

The Solon Township Board approves amending the existing Townline Division as follows:  
Solon Township agrees to assume responsibly for local government obligations associated with maintenance and construction of the portions of 16 Mile Road from Algoma Avenue west to Pennington Avenue conditioned upon Algoma Township agreeing to assume responsibility for local government obligations associated with maintenance and construction for the portion of 16 Mile Road from Algoma Avenue East 1 mile.

All other existing maintenance obligations for the remaining portions of 16 Mile Road shall remain unchanged.
