Outside of Station Functions, Significant Events, Alarms:

- The annual Firefighter's Appreciation Dinner occurred on 10-25-2020 at the Sparta Lanes at 1600 hours. Service Awards and Badge Pinning Ceremony was the first item on the agenda. Celebrating 5 years of dedicated service are Firefighters Hunt and Schievink. Next on the agenda was bowling, dinner was served at 1800 hours and door prizes were raffled prior to departure. The coveted door prizes this year were two sets of corn hole boards manufactured by Cornhole America of Cedar Springs, MI. One pair was donated from Cornhole America, and the other set was purchased and donated by the SOF officer group.
- A new property owner in the township has donated the use of an existing 1960's era, 1500 sq. ft., wood frame, ranch style home to the FD for training purposes. The home sits on 80 acres at 17643 Albrecht NE, Cedar Springs MI. The property owner has given the FD permission to access the home as work on the necessary liability requirements continues for the FD to raze the building. The property owner has intentions to build a log home on the property. This home is in near live-in condition and will provide a tremendous training opportunity. Other public safety agencies have been given access to the property and a few have reserved dates already including Grand Rapids and Kentwood PD
- On 10-27-2020 SFD responded to 443 Solon Road NE with auto aid from Kent City, Algoma, and Sand Lake Fire Departments on a report of a detached garage fire. SFD Engine 1 arrived on scene with two personnel and was able to extinguish the fire with the garden hose that the property owner was using to try and extinguish. Auto aid partners were cancelled prior to arrival. The garage was ventilated to remove the smoke. An investigation for cause and origin was leaning toward a problem with the pellet stove.

- On 10-28-2020, The first day of the Bad Day Industries, Medical First Responder course was hosted at the Solon Fire Department (SFD). SFD will be sponsored as a satellite location under the MDHHS approved medical training site for the Plainfield Fire Department. This class has 14 students enrolled and will be mostly virtual instruction with Covid 19 compliant practical dates. SFD has three students enrolled in the class. The class has been approved for MFFTC Fireworks funding if a minimum of 15 students enroll. The Course Manager has applied to the MFFTC Regional manager for an exemption on this requirement. A decision will be forthcoming.
