• PFAS Letters:

A motion was made by Hoskins to approve sending out letters using the letter recommended by our lawyer to residents between 16 and 17 Mile, and from Algoma east to Northland Drive, seconded by Willoughby. Motion carried 3-0.

<u>Discussion Items:</u> Hydrovac Settlement Proposal: We will ask the attorney to have them stop dumping and to do a full scope of environmental testing on the site.

Trustee Hoskins: The Planning Commission is still working on the master plan. Will ask Jerry from KCRC to send letter to MDOT to let them know what we've approved along 17 Mile so they know what traffic will look like in the future.

Clerk: We had 24% turnout in the State Primary Election. Approximately 59% of Solon votes came from absentee ballots. Early voting we had 63 voters over 9 days, costing the Township approximately \$133 per voter.

Supervisor: Wiersma is based all the way to White Creek.
